Who we may share your information with

How long we keep your information

How we protect your information

We always hold your information securely and to avoid unlawful disclosure or access to your information. We also follow strict procedures to ensure we work with all personal data in line with current data protection legislation.

Controlling information about you

We may ask you for more such information from time to time, and we will store this information with information we already keep about you. Your rights over your information
